He served as lead counsel in the certification proceedings for the Balsam Meadow Hydroelectric Pump-Storage Power Plant, as well as three related lawsuits filed in state court.

Four years specializing in land use environmental matters, including dozens of eminent domain cases and writ proceedings. He authored dozens of official City Attorney Opinions and tried cases involving CEQA compliance, planning and zoning decisions, and the issuance of subdivision maps. For two years he represented the Los Angeles Department of Water and Power in air quality and other environmental state and federal regulatory proceedings, primarily before the California Energy Commission and California Air Resources Board. Tried and argued civil cases at every level of state and federal trial and appellate courts, except the United States Supreme Court.
