Hon. Suzanne G. Bruguera (Ret.) joins ADR Services, Inc. after 27 years as a judge of the Los Angeles Superior and former Municipal Courts, with the entirety of her time on the bench spent in civil assignments. Judge Bruguera's judicial career was preceded by experience as a Deputy Attorney General for the California State Department of Justice, where she handled complex business and tax matters and Medi-Cal fraud for nearly five years. Prior to that, she was a Deputy District Attorney for the County of Los Angeles and spent a year in private practice.
