Those who appeared before me in Department 71 of the Stanley Mosk Courthouse soon became aware of my deep respect, admiration, and affection for attorneys. Thank you for the honor and privilege of twenty-seven years as a judge in Los Angeles.

I proudly served as a Judge for the County of Los Angeles, having been appointed by Governor George Deukmejian in 1989, for 10 years on the Municipal Court and 17 years on the Superior Court. All of my assignments were in civil courtrooms. As an independent calendar judge, I was assigned to handle unlimited civil cases from filing to final adjudication. I had a caseload of approximately 460 active and 150 inactive cases at the time of my retirement. I held this assignment for nearly 20 years, until I retired from the bench in 2017 to join ADR Services, Inc.

Joining ADR Services, Inc. is a natural progression for me because, on the bench, I explored settlement of my cases at every opportunity and have pride in my success rate. I developed settlement skills because, being able to settle my own cases and those of my colleagues was crucial for all of us to handle such large caseloads. I particularly take pride in having settled matters which other settlement officers previously could not. Although there is no magic key to settlement except preparation, I believe in exercising patience and in creating an opportunity for people to reach an agreement without being judged or humiliated. I allow people to save face, and I never give up, which is crucial to consistently bringing matters to resolution.
