His respect for the emotional dynamics between the parties, as well as his thorough understanding of the facts and law, allow him to build credibility with the parties and their counsel while crafting settlement scenarios to ensure resolution.

As a trial lawyer, Mr. Collier's practice has focused on trust and probate litigation for the past 15 years. He has represented beneficiaries and trustees, both individual and institutional, in removal and surcharge proceedings, cases involving interpretation and modification of trusts, and will and trust contests. Mr. Collier was recognized as a Northern California Super Lawyer in Probate and Trust Litigation for nine consecutive years.
