Mr. Bening is an insurance coverage specialist, having represented both insureds and insurers in diverse matters for more than 25 years. He is recognized by both plaintiff and defense counsel as having a keen understanding of their perspectives, and is often selected as the mediator in cases where coverage for one or more defendants is at issue - many times in matters more significant than the dispute in litigation.
