Elimination of bias begins first with the acknowledgement that we each have biases – it is unavoidable. The term bias refers to the tendency of a person to favor one thing, idea, or person over another. In the law, some biases are useful, for example of the voir dire of a jury. Others, however, conflict with protected classes and become unlawful. For Judges, the standard is even higher, as they strive to review each matter through a completely unbiased lens.
